#### **Prospective Board Member**

Applicants interested in serving as a board member should first read and understand the expectations and rules of Board membership, read, and understand the library's mission statement, and submit a completed application in a timely fashion.

A candidate for election as a Trustee must be a legal resident of the Newfane Central School District of Newfane, New York (the "District"), and must have been eligible to vote in the previous District election and otherwise meet the requirements for election as a Trustee set forth in applicable provisions of the Education Law. Trustees shall be elected by the eligible voters of the District in accordance with those provisions.

Newfane Public Library Board of Trustees are charged with five primary responsibilities:

- 1. Advocate for the library in the community and advocate for the community as a member of the library board.
- 2. Plan for the future of the library.
- 3. Monitor and evaluate the overall effectiveness of the library.
- 4. Set library policies.
- 5. Hire and evaluate the library director.

Newfane Public Library Board of Trustees expectations:

- Support the mission of the Newfane Public Library
- Work as part of a cohesive team with common goals.
- Share skills and expertise.
- Dedicate time to attend board meetings.
- Have no more than three absences from board meetings per year.
- Participate actively in Board meetings, committees, fundraisers, and library events.
- Respect and support the majority decisions of the Board.
- Represent all those whom the library serves.
- Declare conflicts of interest as it pertains to your position on the Board and abstain from voting when appropriate.


